Award & Eligibility

One \$250.00 scholarship will be awarded.

Eligibility is open to all Clarence High School AOBF students who are high school seniors attending an accredited college, university or other institution of higher learning during the next academic year.

Application Process

To apply, eligible students will need the following items:

- Completed application (must include the name of the accredited college, university or other institution of higher learning that you will be attending during the next academic year).
- High school transcripts (official transcripts are not necessary).
- Letter of Recommendation from a District teacher, guidance counselor, coach or administrator.
- Typed, double spaced 300-500 word essay on how the Academy has helped strengthen your financial literacy skills.

Selection Process & Deadline

All eligible applications and essays will be evaluated by the Scholarship Committee. The recipient will be notified and announced at the Academy Recognition Ceremony in May. The Scholarship Committee's decision is final. Applications must be submitted to the credit union office to arrive no later than **Monday, April 17, 2023.**
